## September 04, 2019

The regular meeting of the Town Board of the Town of Colchester, Delaware County, New York was held on Wednesday, September 04, 2019 at 7:00 PM at the Town Hall.

The Meeting was called to order by Supervisor Arthur M. Merrill and led the group in the Pledge of Allegiance.

The minutes of the last regular meeting, August 21, 2019 had been distributed earlier. Janet Champlin made the motion to accept the minutes as written, seconded by Mark Mattson, all in favor, motion carried.

GUESTS: Jeff Francisco of Delaware Engineering reported that he received confirmation that we can get an increase in our DWSRF Loan; may need a new Bond Resolution; we are in the process of scheduling a conference call with all interested parties; checking with low bidder of the Downsville Water System Improvement Project DWSRF #17537: Contract #TC1-G-2019 if they will still honor their bid; if everything goes as planned we could start construction this year.

VISITOR COMMENTS: Joan Homovich inquired if the EIS for the Park Project is posted. Supervisor replied no. Ms. Homovich asked if FEMA approved the bridge; she saw the FEMA Approved sign in Shinhopple. Supervisor replied that there is no such thing, the property owner put up the sign. Ms. Homovich inquired if the meetings of the Revitalization Committee would be posted for public to attend. Supervisor replied probably.

Supervisor Merrill reported that we need to make a request for funds for the Downsville Water District Improvement Project, DWSRF D0-17537 in the amount of \$4,231.31. Board discussed. NO. 96-2019 09/04/19 DWSRF 17537 Requisition No. 4

The resolution was declared to be duly adopted by the members of the Town Board of the Town of Colchester.

Supervisor reported that the trusses are being installed in the addition of the Cooks Falls Highway Garage; there was a problem of bees there.

Supervisor Merrill reported that there is a voucher in tonight for the Gregory Hollow Road Stream Crossing Project (Tiffany Hollow Culvert) from DOIG Excavating, Inc., we will requesting the funds from the Dept. of the Interior for reimbursement.

Highway Supt Kenneth Eck reported that bids are due Sept. 11<sup>th</sup> for the 4x4 Pickup Truck.

Highway Supt Eck reported that it will cost more than \$20,000 for a new motor for truck #116, a 2012 Ram 5500; he recommends to replace the injectors, approximately \$11,000.

Supervisor is looking at the 2020 Budget and would like to know what other pool repairs are needed or wished for. Committee recommends: need hot water tank (Councilman Lavorgna can get one); lettering on pool; finish drains; pool vacuum; concrete under pavilions and drop the ceilings (Highway Dept. will do); new gate doors; and paint the bathhouse floors gray and not gray and make not slippery.

Supervisor added that if anyone has a special project or additional costs for next year, they need to see him for budget information.

Supervisor Merrill reported that the new mandated Sexual Harassment Prevention Training video has been downloaded to his and the Town Clerk's computers; we need to get the word out to all employees; Supervisor was hoping the County would get it on the County Website so anyone could review it.

Highway Supt Eck reported that GeoStabilization International (GSI) has stated that soil nails would not provide an effective repair at the site of Horse Brook Road; we have put in rocks and they sink; there are two part-time residents on the road; we will continue to do our best in repairing this road.

Highway Supt Eck reported that GeoStabilization International (GSI) has presented a Roadway Stabilization Proposal for Campbell Mtn. Road at the project cost of \$124,472.00 with a five year warranty; they could start end of September/beginning of October. Board discussed.

Supervisor Merrill reported that we have been replacing some of the lights at Town Hall over the past couple of years; we have recently ordered new lights to complete the replacement project at Town Hall.

Supervisor reported that he received a phone call today from a contractor, who was looking for a place to mobilize their equipment for the NYS Route 30 Project; they plan to bring in equipment next week; they will start grinding the road; Highway Dept. will take any extra millings.

Highway Supt. Kenneth Eck reported that we have received an estimate from Tracey Road Equipment to paint the dump body/box of the 2015 Freightliner; this truck was used on Cat Hollow and will go to Cooks Falls once we receive the new Freightliner. Board discussed.

Councilwoman Markert inquired how the recent burial went, now that employees have changed. Supervisor replied fine and reported that HEO Dan Bennett helped out.

Board held discussion on a sign for Cooks Falls Court and our LED sign at the end of town.

Town Attorney Michael DeGroat gave an update on the litigation of the petition received on the permissive referendum regarding police building and the Supervisor's challenge of their petition: Court decided that the petition was premature and the motion was denied, making the petition invalidated; the Board did nothing at the time to warrant a permissive referendum; the petition was premature; it is behind us now; Town Attorney stated that he had about forty hours on this. Supervisor thanked Town Attorney DeGroat for all of his hard work.

Joan Homovich asked if a pipeline was going through Downsville; she had heard this on Channel 12 News. Supervisor commented that he was not aware of this.

Julie Markert made the motion to go into executive session to discuss Police personnel, Highway personnel and contract negotiations, seconded by Greg Lavorgna, all in favor, motion carried. Board entered executive session at 8:05PM. Town Attorney, Town Clerk and Hwy Supt were invited to stay. Board held discussion. Mark Mattson made the motion to enter back into regular session, seconded by Julie Markert, all in favor, motion carried. Board entered regular session at 8:36PM. WHEREAS, on May 01, 2019 the Town Board of the Town of Colchester adopted Local Law No. 1-2019; and

WHEREAS, the purpose of said Local Law is to permit the Town of Colchester, New York, to change from an elected Board of Assessors to a single appointed Assessor. It is adopted pursuant to New York Real Property Tax Law Section 328 and New York Municipal Home Rule Law Section 10; and

WHEREAS, NYS Department of Taxation and Finance mandates the term of office for Appointed Sole Assessor, a six year term beginning October 01, 2019 to September 30, 2025;

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Colchester hereby appoints D. Joseph Gifford as Assessor Assistant for the term beginning October 01, 2019 to December 31, 2019;

BE IT FURTHER RESOLVED that the Town Board of the Town of Colchester hereby appoints D. Joseph Gifford as Sole Appointed Assessor for the term beginning January 01, 2020 to September 30, 2025 with a starting salary of \$25,000.00 annually.

Resolution was seconded by Julie Markert, all in favor, resolution declared adopted.

With no further business, Janet Champlin made the motion for adjournment, seconded by Mark Mattson, all in favor, motion carried. Meeting adjourned at 8:40 PM.
